International Context

International Labour Organization (ILO)

The main aims of the ILO are to promote rights at work, encourage decent employment opportunities, enhance social protection, and strengthen dialogue on work-related issues. The ILO website includes data, reports, global information and articles useful and related to labor trafficking.

 Non-binding principles and guidelines for a rights-based approach to labour migration
- Palermo Protocol (UN Human Rights Office of the High Commissioner, 2000)
 Adopted in 2000, the first global, legally binding instrument with an agreed definition of trafficking in persons; increased awareness surrounding the problem of human trafficking and gave the international community standards by which nations could more effectively address human trafficking

Legal Framework

 Enhances and offers additional language related to contractors that are prohibited from conducting human trafficking related activities
- Trade and Facilitation and Trade Enforcement Act (Congress.gov, 2015)
 Comprehensive authorization with the overall objective to ensure a fair and competitive trade environment. Among other components, this act supports the modernization processes of global supply chains.



Key Federal Agencies

 U.S. Department of Health and Human Services (HHS), Office on Trafficking in Persons (OTIP)

The Office on Trafficking in Persons (OTIP) is responsible for the development of antitrafficking strategies, policies, and programs to prevent human trafficking, build health and human service capacity to respond to human trafficking, increase victim identification and access to services, and strengthen health and well-being outcomes of trafficking survivors. OTIP funds the National Human Trafficking Hotline and victim assistance grants, issues Certification and Child Eligibility Letters, and offers training and support to the field. • U.S. Department of Justice (DOJ)

The Department's anti-trafficking efforts involve numerous components engaged investigations, prosecutions, services for victims, trainings, enforcement and outreach initiatives to strengthen anti-trafficking partnerships, innovative prevention efforts, capacity-building programs that advance survivor-centered anti-trafficking strategies, and grant funding to state, local, and tribal authorities and to non-governmental organizations (NGOs). - Attorney General's Trafficking in Persons Report
 This annual report describes the U.S. Government's comprehensive campaign to
 combat human trafficking including efforts to carry out the 3Ps strategy to (1)
 protect victims by providing benefits and services; (2) investigate and prosecute
 human trafficking crimes; and (3) prevent further trafficking-related crimes.
- Federal Strategic Action Plan on Services for Victims of Human Trafficking in the United States (2013-2017)

A coordinated effort of the President's Interagency Task Force to Monitor and Combat Trafficking in Persons that incorporates input from survivors and other experts in the field. The plan identifies core values related to trafficking victims' services and key areas for improving service delivery, and lays out four goals, eight objectives, and contains more than 250 associated action items for victim service improvements to be achieved during a five-year period.



U.S. Department of Labor

Has an important role to play in combating trafficking in persons through civil enforcement of federal labor laws, research and funding for grants overseas, and employment and training expertise. Through the Wage and Hour Division's civil enforcement, in particular, DOL partners with federal law enforcement agencies around the identification and referral of potential instances of trafficking in persons and the calculation of restitution amounts for victims.

U.S. Department of Homeland Security

Responsible for investigating human trafficking, arresting traffickers and protecting victims. DHS initiates hundreds of investigations and makes numerous arrests every year, using a victim-centered approach. DHS also processes immigration relief through Continued Presence (CP), T visas, and U visas to victims of human trafficking and other designated crimes.

National public awareness campaign designed to educate the public, law enforcement and other industry partners to recognize the indicators of human trafficking, and how to appropriately respond to possible cases.

U.S. Department of State, Office to Monitor and Combat Trafficking in Persons
The TIP Office leads the Department's global efforts to combat human trafficking through
the prosecution of traffickers, the protection of victims, and the prevention of human
trafficking by: objectively analyzing government efforts and identifying global trends,
engaging in and supporting strategic bilateral and multilateral diplomacy, targeting foreign
assistance to build sustainable capacity of governments and civil society, advancing the
coordination of federal anti-trafficking policies across agencies, managing and leveraging
operational resources to achieve strategic priorities, and engaging and partnering with civil
society, the private sector, and the public to advance the fight against human trafficking.



TIP Report (U.S. Department of State, 2021)
 U.S. Government's principal diplomatic tool to engage foreign governments on human trafficking. It is also the world's most comprehensive resource of governmental anti-trafficking efforts and reflects the U.S. Government's commitment to global leadership on this key human rights and law enforcement issue.

Promoting Employment Opportunities for Survivors of Trafficking (PEOST) Training and Technical Assistance Project (Futures Without Violence)

In cooperation with the Office for Victims of Crime (OVC), PEOST aims to increase access to quality educational and employment opportunities for survivors of human trafficking. In partnership with a working group of experts with both lived and professional experience, training and technical assistance is provided to victim service providers, with a special emphasis on current OVC human trafficking grantees, as well as workforce development programs.

Polaris

Operates the National Human Trafficking Hotline; uses data to inform how trafficking is identified, how victims and survivors are assisted, and how communities, businesses and governments can prevent human trafficking by transforming the underlying inequities and oppressions that make it possible.

National Human Trafficking Hotline

Connects victims and survivors of sex and labor trafficking with services and supports. The Trafficking Hotline also receives tips about potential situations of sex and labor trafficking and facilitates reporting that information to the appropriate authorities in certain cases. The toll-free phone and SMS text lines and live online chat function are available 24 hours a day, 7 days a week, 365 days a year. Help is available in English or Spanish, or in more than 200 additional languages through an on-call interpreter.

 Reporting Undercover: Labor Trafficking and the Underground Chinese Restaurant Network (Amelia Pang, 2016)

In this investigative piece from Amelia Pang, a journalist who posed as a Chinese immigrant looking for work as a busgirl, Pang details her journey from contacting an employment agency to traveling to the job site to the working conditions in the restaurant.

 Mars, Nestle and Hershey to Face Child Slavery Lawsuit in U.S. (The Guardian, 2021)

This article discusses companies like Nestlé, Cargill, Barry Callebaut, Mars, Olam, Hershey and Mondelēz that have been named as defendants in a lawsuit by the human rights firm International Rights Advocates (IRA) on behalf of eight former enslaved children who say they were forced to work without pay on cocoa plantations. This is the first time that a class action of this kind has been filed against the cocoa industry in a US court.

 Dilemma and Case Studies on Human Trafficking (Human Rights and Business Dilemmas Forum, 2021)
